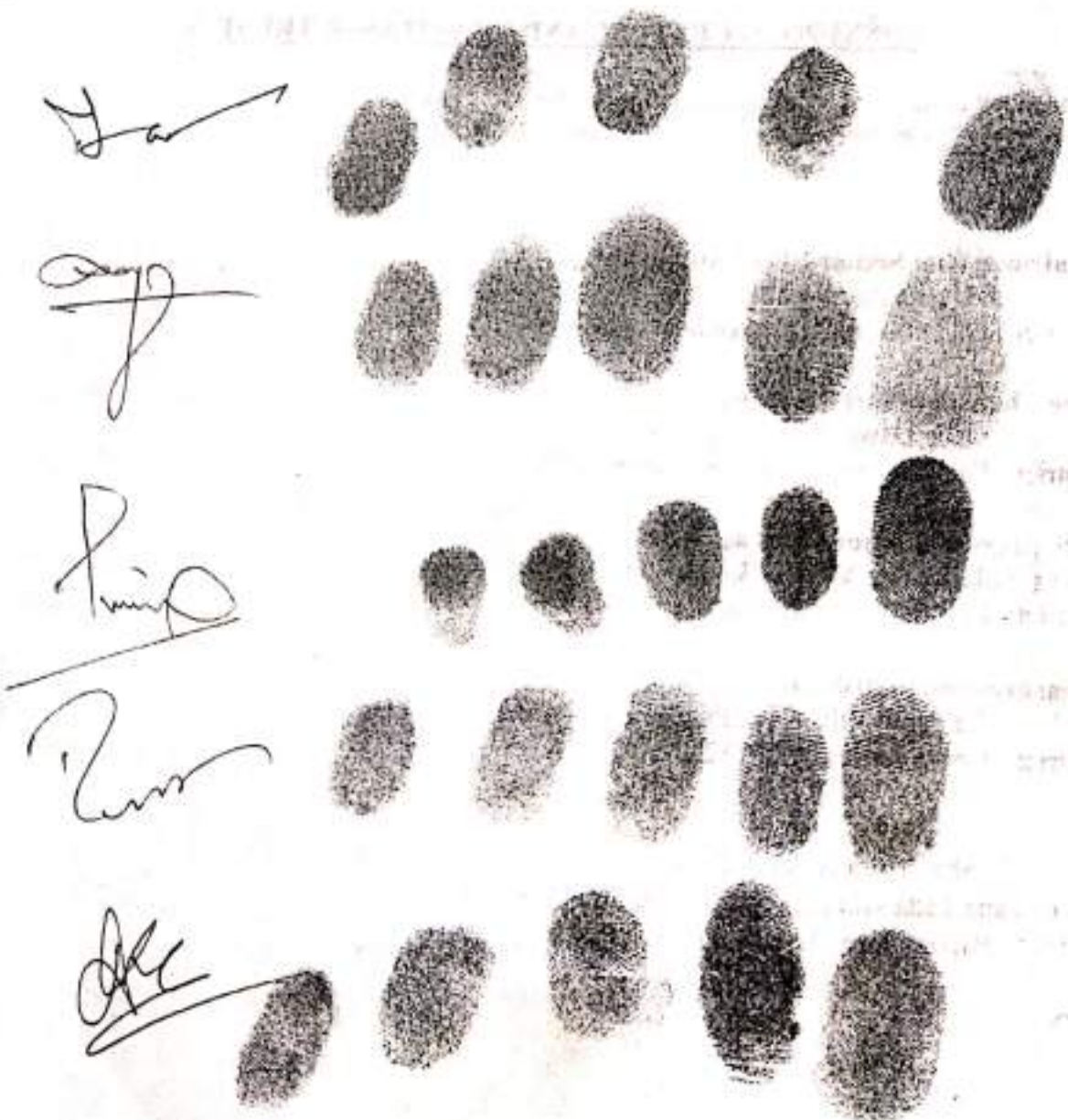

20. When vacancy arises in the office of the Trustee by resignation, death or otherwise, the other Trustees may at any person as a trustee to fill up such vacancy in the Board of Trustees.
21. The trustees shall meet atleast once in three months or in such early periodicity to carry out the various activities of the trust. The proceedings of such meeting shall be recorded in a minute book which will be a conclusive evidence and authority for the Board's decision.
22. Three (3) members shall form the quorum for conducting the meeting of the trustees.
